**DDA:** Meeting was January 20, 2021 at 6:30 via zoom. The Board discussed the proposed lighting project from M52 west to Signature Ford. The annual SEDP pledge was approved in the amount of \$2500.

**Library:** Then local libraries are supplying IRS tax forms to residents. They have been doing curbside book pickup and have continued children's programs.

to the county zoning administrator acknowledging the gravel pit has been operational since before the County's 1982 zoning ordinance and should be considered "grand fathered in" as an existing non-conforming use and that any future changes should follow the procedures for handling any other non-conforming use.
