* Holiday rentals will be required to rent the next day after their event for an additional \$50.00 or be cleaned up and out of the Hall by 10:00 pm. Holidays are defined as the day before, day of and the day after the recognized holidays. Recognized holidays are New Years Eve, New Years Day, Easter, Memorial Day, July 4th, Labor Day, Thanksgiving, Christmas Eve, Christmas Day.

* If the renter wants to setup/decorate the day prior to, there is a \$50.00 rental fee.

REQUIREMENTS:

A deposit is required within 10 days after request to hold date. The deposit will be refunded at the discretion of the custodian. An ACORD form must be filed for all rentals having alcohol.

To receive the township rental rate, **the renter must be a resident or taxpayer of Perry Township and may only rent for immediate family. (Immediate family member means Spouse, Mother, Father, Sister, Brother, Daughter, Son, Grandparent or Grandchild.) If the Immediate family member is not a resident they must co-rent with the immediate family member that is a resident or taxpayer. Both renters must sign the agreement.**
