Regular Meeting Minutes
April 3, 2024

Present: Mark Fulks, Supervisor; Kelly Schmidt, Clerk; Troy Parmalee, Treasurer; Mark Fraser and Frances Griffith, Trustees.

Guests: John Slocum, Trent Atkins, Dennis Malloy, Robert Hinojosa.

The Supervisor opened the meeting with the pledge to the flag.

The **agenda was approved**. Parmalee moved; Fraser seconded. All ayes Carried.

The **March 6, 2024 Regular Meeting Minutes were approved**. Fraser moved; Griffith seconded. All ayes Carried.

Sheriff Report: 32 traffic stops; 123 total calls for the month.

SSESA: Interim Chief Atkins reported there were 20% more EMS runs from last year. There were 2 resolutions passed on being an increase from \$110 to \$120 for ambulance services. This increase is due to the increased costs of medical equipment, vehicle maintenance and increase salaries of 16 full time employees per contract. The second resolution was to request a ½ mill increase from 1.25 to 1.75 mill for 2 years for equipment, apparatus, etc. at the August election.

The **financial statement was approved to pay the bills**. Fraser moved; Griffith seconded. Roll Call: Fulks, Fraser, Griffith, Schmidt, Parmalee. All ayes Carried.

Public Comment: Robert Hinojosa announced he is running for Shiawassee County Prosecuting Attorney in August. John Slocum made comment that the skip grading has pushed sod into the ditches and he's unable to mow them now. He also made comment that he felt an error was made on his tax payment causing one parcel to go delinquent.

New Business:

- The **Waste Management contracts** for the Hall dumpster in the amount of \$237.47 per month for 3 years and the Cemetery dumpster in the amount of \$210.33 on a will call basis for 3 years was approved. Schmidt moved; Griffith seconded. Roll Call: Griffith, Schmidt, Parmalee, Fulks, Fraser. All ayes. Carried.
- The **Ambulance Services Proposition language** to renew the existing emergency services (ambulance) special assessment district for Perry Township excluding the Village of Morrice was approved. Fraser moved; Fulks seconded. Roll Call: Fulks, Fraser, Griffith, Schmidt, Parmalee. All ayes Carried.
- The Supervisor gave a **March Board of Review report**. March 12 the Board reviewed 1 property exemption; 11 corrections. March 13 they reviewed 8 personal property. March 17, 1 property class change was made.
- The **Board approved a bid from Mike Godfry to do bathroom renovations up to \$12,000**. Fraser moved; Griffith seconded. Roll Call: Schmidt, Parmalee, Fulks, Fraser, Griffith. All ayes Carried.
