Regular Meeting Minutes
July 31, 2024

Present: Mark Fulks, Supervisor; Kelly Schmidt, Clerk; Troy Parmalee, Treasurer, Mark Fraser and Frances Griffith, Trustees.

The Supervisor opened the meeting with the pledge to the flag.

The **agenda was approved with additions**. Fraser moved; Griffith seconded. All ayes Carried.

The **July 3, 2024 Regular Meeting Minutes were approved**. Parmalee moved; Fraser seconded. All ayes Carried.

Public Comment: Travis Smith reported that the island in Rose Blvd is finished.

Sheriff: 52 traffic stops; 159 total calls for the month

SSESA: Ambulance response time for June 2024 was 8 min 48 sec vs June 2023 at 9 min 2 sec.
There will be a .5 mill for 2 years for fire equipment on the Aug 6 2024 ballot.

DDA: Met on July 17th. The 1.6 million dollar water project is still under review for a grant.
Lifetime Metals will be having a ribbon cutting on Friday, Aug 16th.

Library: There will be a millage renewal on the Aug 6 2024 ballot. The summer reading programs are under way at both of the Perry and Morrice locations.

The **financial statement was approved to pay the bills**. Fraser moved; Griffith seconded. Roll Call: Fulks, Fraser, Griffith, Schmidt. All ayes Carried.

Correspondence: Received a notice from the County to update the solid waste plan.

- Fulks gave the **July Board of Review update**. There were 2 veterans adjustments and 4 error or omission corrections.
- The Planning Commission recommended to the Township Board to approve the **Rothney Application Request #PZBA24-010**. Parmalee moved; Fraser seconded to tentatively approve the recommendation subject to the Township Planning Commission's review of the staff report. Roll Call: Fulks, Fraser, Griffith, Schmidt, Parmalee. All ayes Carried.
- Beth Andrus requested to attend a class called Hot Topics for Planning & Zoning.
- A request to purchase **mulch for the Township Hall was approved** up to \$400. Parmalee moved; Griffith seconded. Roll Call: Schmidt, Parmalee, Fulks, Fraser, Griffith. All ayes Carried.
- The **annual contribution to SEDP was approved** in the amount of \$3556. Parmalee moved; Fulks seconded. Roll Call: Parmalee, Fulks, Fraser, Griffith, Schmidt. All ayes Carried.
